This trip has been organized by Benefactor Travel (BT) for members of the American Horticultural Society (AHS).

RESERVATION AND PAYMENT

A deposit of \$1,000 per person confirms your reservation. You will receive confirmation of your reservation by mail within 30 days of receipt of your deposit. If you make your reservation after the final payment due date, payment in full will be required when you make your reservation. Final payment is due 90 days prior to trip departure and an invoice will be sent in advance of this date. **The final payment for the 2017 Gardens of Argentina: Buenos Aires, Mendoza & Salta tour will be due July 30, 2017.**

including if there are too few participants, a full refund of all payments received will be made. The AHS and the tour organizer are not responsible for any loss incurred on account of non-refundable or non-transferable air tickets or other unrecoverable costs.

CURRENCY FLUCTUATIONS AND PRICE GUARANTEE

At the time of printing, prices were correct. However, fluctuations in the exchange rates may result in the need to amend the price. Once payment is made in full, price will be guaranteed as stated.

ALTERATIONS TO ITINERARY
